

SENATE BILL NO. 130

March 06, 2025, Introduced by Senators SINGH and LAUWERS and referred to Committee on Regulatory Affairs.

A bill to amend 1979 PA 152, entitled "State license fee act," by amending sections 9 and 25 (MCL 338.2209 and 338.2225), section 9 as amended by 1988 PA 461 and section 25 as amended by 2023 PA 131.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 9. The department may charge a fee for the publication
2 and distribution of the public act ~~from which~~ **that provides** a
3 board's authority ~~is derived~~ and the rules promulgated under that
4 act. The fee ~~shall be \$2.00 or~~ **is** the cost of the publication. 7

15 (2) At the beginning of each state fiscal year, the department
 16 may increase the fees collected under subsection (1) by a
 17 percentage amount equal to not more than the average percentage
 18 wage and salary increase granted for that state fiscal year to
 19 classified civil service employees employed by the department.

20 (3) If the department increases fees under subsection (2), the
 21 increase is effective for that state fiscal year. The department
 22 shall use the increased fees as the basis for calculating fee
 23 increases in subsequent state fiscal years.

24 (4) By August 1 of each year, the department shall provide to
 25 the director of the department of technology, management, and
 26 budget and the chairpersons of the appropriations committees of the
 27 senate and house of representatives a complete schedule of fees to
 28 be collected under subsection (1) for the following state fiscal
 29 year.

1 Enacting section 1. This amendatory act does not take effect
2 unless Senate Bill No. 131 of the 103rd Legislature is enacted into
3 law.
