## HOUSE RESOLUTION NO. 166

The Speaker, on behalf of the entire membership of the House of Representatives, offered the following resolution:

- 1 A resolution of tribute offered as a memorial for Shelley
- 2 Goodman Taub, former member of the House of Representatives.
- 3 Whereas, It is with great sorrow that we learned of the
- 4 passing of Shelley Goodman Taub, who served with distinction as the
- 5 Representative of the former Fortieth District from 2003 to 2006.
- 6 She will be remembered always as a dedicated public servant not
- 7 only by those she represented in the Oakland County area, but by
- 8 the state of Michigan as a whole; and
- 9 Whereas, Shelley Goodman Taub was born in Detroit and attended
- 10 the University of Michigan, where she received her degree in
- 11 education. Along with her husband, Steve, who she married in 1961,
- 12 Shelley traveled across the country, living in Missouri, Arizona,
- 13 and California before returning home in 1969. For three decades,

- 1 Shelley dedicated her life to serving those around her as a
- 2 schoolteacher and medical office manager. From 1993 to 2002,
- 3 Shelley served her future constituency as an Oakland County
- 4 Commissioner, demonstrating a deep commitment to her community and
- 5 drive toward public service. This drive would launch her journey to
- 6 statewide service, which culminated in a successful bid for the
- 7 Fortieth District seat in the Michigan House of Representatives in
- 8 2002; and
- 9 Whereas, Shelley's two-term tenure in the Michigan House of
- 10 Representatives began in 2003 and, upon arrival in this Chamber,
- 11 she demonstrated her tenacity and commitment to the office by
- 12 serving as chair of the House Appropriations Subcommittee on
- 13 General Government and as vice chair of the Appropriations
- 14 Subcommittee on State Police/Military and Veterans Affairs.
- 15 Throughout her time in the Legislature, Shelley also served with
- 16 distinction as chair of the House Appropriations Subcommittee on
- 17 Transportation and as vice chair of the Appropriations Subcommittee
- 18 on History, Arts and Libraries. She also served as a member of the
- 19 House Appropriations Subcommittee on Community Health and as a
- 20 member of the Medicaid Task Force. During her second term in this
- 21 Chamber, Shelley also served as the majority caucus vice chair.
- 22 These roles exemplified her interest in serving her constituents in
- 23 furtherance of a variety of matters important to her, including the
- 24 health and well-being of Michiganders statewide; and
- 25 Whereas, Shelley's priorities in government were also
- 26 reflected in her professional and personal activities following her
- 27 service to this Chamber. Initially intending to retire from public
- 28 service in 2007, Shelley ultimately found the task impossible in
- 29 2009, she once again successfully ran for a seat on the Oakland

- 1 County Commission. She would remain in public service as a member
- 2 of that body until 2020; in total, Shelley served Oakland County in
- 3 that role for 20 years. During her tenure as a commissioner,
- 4 Shelley championed an appropriation of over two million dollars in
- 5 federal funding to support cultural institutions negatively
- 6 impacted by the COVID-19 pandemic, which reflected her deep
- 7 devotion to supporting development of the arts in Oakland County
- 8 and statewide. From 2009 to 2020, Shelley was a member of the
- 9 National Association of Counties' Arts and Culture Commission,
- 10 which she chaired from 2019 to 2020. She also served the
- 11 organization as vice chair of its Human Services and Education
- 12 Steering Committee. In 2016, Shelley was elected as the president
- 13 of the Michigan Association of Counties, an organization she had
- 14 been a board member of since 2012. Those who knew her would not be
- 15 surprised at these accomplishments, as her passion and skill in
- 16 serving the interests of the community she loved were evident, and
- 17 these qualities are what she will always be remembered for; and
- 18 Whereas, Along with recognizing Shelley's contributions to
- 19 this Chamber as well as to our state as a whole, we also offer our
- 20 condolences to her loved ones. We guarantee to her three children -
- 21 Adam, Jennifer, and Andrew and each of their families that
- 22 Shelley's accomplishments and years of service to the Legislature,
- 23 Oakland County, and the state of Michigan shall always be
- 24 remembered; now, therefore, be it
- 25 Resolved by the House of Representatives, That we offer this
- 26 expression of our highest tribute to honor the memory of Shelley
- 27 Goodman Taub, a member of the House of Representatives from 2003 to
- 28 2006; and be it further
- 29 Resolved, That copies of this resolution be transmitted to the

1 Taub family as evidence of our lasting esteem for her memory.
